### PROF. ILAN ALON

The College of Management Academic Studies

Prof. Ilan Alon is the Dean and Full Professor of the School of Economics at the College of Management Academic Studies. He previously held positions at Harvard University, Georgetown University and Copenhagen Business School. His publications on cryptoeconomics and international business have been cited over 14,000 times. He is also the editor-in-chief of the International Journal of Emerging Markets.

### PROF. ODED STARK

University of Bonn, University of Warsaw

Prof. Oded Stark is Distinguished Fellow at the University of Bonn, Distinguished Professor at the University of Warsaw, and Adjunct Professor at the University of Tübingen. His previous affiliations include, for example, Harvard University and Georgetown University. In the RePEc / IDEAS ranking of economics professors, he is listed in the top 1% in Europe and in the world.

## SPECIAL SESSION ON PROFIT SHIFTING

We seek theoretical and empirical research on topics like corporate governance's impact, reporting's role, and regulatory influence. Themes may include non-financial corporations' balance of payments and investment positions in passive income transfers.
